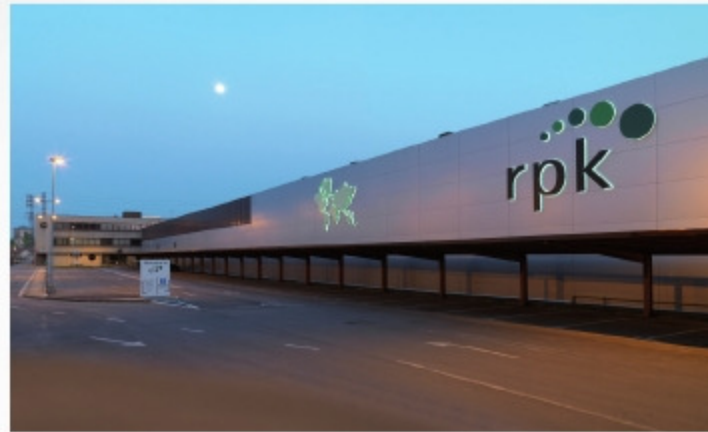

- 1974** > **RPK** is founded in Vitoria-Gasteiz by 19 entrepreneurs.
- 2002** > The first production facility outside Europe, **RPK Mexico** become the platform to supply customers in NA.
- 2006** > **RPK** purchases the company Herckelbout-Dawson Iberica S.A., HEDISA, located in Tarragona, Spain. Nowadays **RPK Metal Forming S.A.U.**
- 2010** > **RPK** begin activities in ASIA by setting up a production facility in Pune, India.
- 2014** > Product diversification investments. **RPK** acquires 3 companies integrated in one called **GASORI**, out of the automotive industry.
- 2015** > A new **Strategic Plan 2015-2018** is developed and a Technical Office opened in Munich-Germany to help our customers.
- 2016** ➤ **RPK Technological Center** is established in Vitoria to enable us to perform FEM, R&D, Laboratory test etc
- 2017** ➤ **RPK China** is under construction in Kunshan, closed to Shanghai, and will be running by April 2018
- 2018** ➤ **RPK USA Technical office in Charlotte (NC)** to be established by the second half of 2018 to help our customers in new developments in Nafta Market
- 2019** ➤ New Strategic Plan 2019-2022 has been released.
